We provide educational support and foster spiritual, character and leadership development for under-privileged students in the Chirilagua neighborhood, primarily through after school tutoring and one-on-one mentoring relationships.

Kids Club: For the 2011-12 school year, 42 students participated in the program. From 1st-4th quarter, Kids Club students increased their overall GPA by 0.35 points across all subjects. In math, 49% of students improved by one or more letter grades and 27% maintained an A or B grade average. In reading, 57% of students improved by one or more letter grades and 19% maintained an A or B average. In homework completion, 41% of students increased by one or more letter grades and 41% maintained an A or B average. Additionally, students earned "Field Trip Points" during each month based on their Kids Club attendance, homework completion, and behavior. In the 2011-12 academic year an average of 94% of students earned their field trip points for each of the 9 field trips. This number constitutes a 5% improvement from 2010-11. For the 2012-13 school year, 40 students are enrolled in the program and are receiving daily academic support and services (as opposed to 2-3 days per week for the previous 2 years). We will not have quantifiable data regarding student academic progress until the current school year concludes in June. Kids Club programming includes: Nutritious snack, math support, homework help, reading support, Bible-based character development lessons, movement lab learning exercises, community service activities, activities in the arts, and monthly

Teens Club: In September 2012, Casa Chirilagua launched its Middle School program, Teens Club. Teens Club provided 19 students with safe, age-appropriate opportunities to promote their social and emotional health and well-being. Teens Club programming includes regular in-school staff/student interaction, facilitation of school/parent/student/staff communication, weekly Teens Club meetings, monthly Experience and Exposure trips, and access to partner-program opportunities such as "Guitars not Guns" and "Wyldlife." For the 2012-13 school year, we will not have quantifiable data regarding student academic progress until the current school year concludes in June.

4c (Code:) (Expenses \$ 15,076 including grants of \$ 15,000) (Revenue \$ 15,000)

Mentoring: In August 2012, Casa Chirilagua spun off from its partnership with "Wright to Read" and started its own independent mentoring program. In its first 6 months of operation, the program supported 50 one-to-one mentoring relationships. During those months, the new Mentoring Director committed the time necessary to actively manage mentoring relationships, established and implemented best practices for the safety of the children and mentors, and improved overall program support for participants. The Mentoring program is an opportunity for Casa Chirilagua youth to build stable relationships with trusting adults and gain access to new experiences and opportunities to help them grow in confidence and reach their full potential. Since this is the program's first year, we will not have quantifiable data regarding student academic progress until the current school year concludes in June.

Form 990, Part III, Line 2 - In August 2012, Casa Chirilagua spun off from its partnership with Wright to Read and started its own free-standing mentoring program that supported 50 one-to-one mentoring relationships. In September 2012, Casa Chirilagua also launched its Middle School program, Teens Club.

Form 990, Part III, Line 3 - For summer 2012, Casa Chirilagua re-vamped its Summer Kids Club program to focus on reading and math interventions for students who are testing below grade level. Rather than meeting from 9am - 1pm for a daily group program, staff, interns, and volunteers visited each participant in his or her home and provided one-on-one reading and math support to prevent summer academic regression.

Form 990, Part VI, Section B, Line 11b - The 990 financial sections are completed by the Casa Chirilagua finance and accounting volunteer, Kevin Sparks. The 990 board governance and narrative sections are completed by the Business Manager, Julia Simerly. The completed form is reviewed by the Executive Director, Dawnielle Miller. The 990 is then submitted to the Casa Chirilagua board. Once the finance committee reviews and approves the 990, it is formally submitted to the IRS.

Form 990, Part VI, Section B, Line 12c - No activities throughout the year were committed which break the Casa Chirilagua conflict of interest policy. In 2012, no contracts were made with an interested party. Any contracts made with interested parties must meet criteria listed in the Casa Chirilagua bylaws and must be presented to and approved by the board of directors.

Form 990, Part VI, Section B, Line 15 - Compensation for both officers, Dawnielle Miller and Emily Mancina, was reviewed and approved unanimously by all independent board members. Compensation was based on a comparability study utilizing salary and employment data taken from the Bureau of Labor Statistics for comparable jobs in the Arlington/Alexandria area of Virginia. The comparability study also included data taken from the National Low-Income Housing Coalition basing pay on the Fair Market Rent rate for the Washington-Arlington-Alexandria area which states that a household must earn \$59,760 annually in order to afford housing at 30% or less of monthly pay.
